Brief Description of Contest/ Programme	 This is the Contest for the TVS live singing competition, TV STARZ 2025, with venue at Miri Indoor Stadium (Mini Stage) (hereinafter referred to as the "Contest") from 20 July 2025 to 21 July 2025. Any eligible person who completes the online registration may audition to be selected by the Company to participate in the said Contest subject to the terms and conditions as set out below. On 20 July 2025, the live audition selection event for participants will be held at 10:00a.m. and semi-final stage at 08:00pm. The final stage event will be held on 21 July 2025 at 08.15pm. The details of the Contest may be subject to further change as notified or communicated by the Company.

5.	Brief mechanism of Contest	1. The prospective Participants (" Participant ") shall register online by scanning the QR code published by the Company on its official website and/or social media platforms. The Participant must provide their full name, email address, phone number, and Identification Card or Passport number (hereinafter referred to as " Registration "). Each Participant may only submit one Registration. Any additional entries by the same Participant will not be accepted.
		2. The Participant shall audition for the Contest by recording and uploading a two (2) minutes audition video of their singing performance during Registration in the required file format. The Participant may choose any song to perform provided that the said song shall not be explicit. The submitted audition video will be subject to the Company's review and approval. The Company's decision on the selection of successful Participants to join the Contest and perform live is final.
		3. Once successfully selected for the Contest, the Participant will receive an email invitation from the Company containing further details and instructions regarding the Contest to perform live at the stipulated time(s) at the specified location(s) (hereinafter referred to as the "Location").

Schedule B (Standard Terms and Conditions)

1. INTRODUCTION

- 1.1. This Contest Standard Terms and Conditions ("Standard T&C") shall govern the Contest that is organized by the Company as named in Schedule A. The Standard T&C and shall be in addition to the terms as set out in Schedule A (Schedule A and the Standard T&C shall collectively be referred to as "Terms and Conditions").
- The Contest will be held during the Contest Period as set out in Schedule A. The Company reserves the right to vary, postpone or re-schedule the dates of the Contest or extend the Contest Period at its sole discretion.
- 1.3. The brief mechanism of the Contest is set out in Schedule A. The Participants must adhere to the mechanism of the Contest as may be briefed and communicated to the Participants by the Company from time to time during the Contest Period.
- 1.4. The Contest will be organized by the Company in the Contest Language as set out in Schedule A.
- 1.5. The Entry Procedure of the Contest is as set out in Schedule A.
- 1.6. The Company reserves the right to at any time, change, amend, delete or add to the Terms and Conditions and other rules and regulations including the mechanism of the Contest at its absolute discretion.
- 1.7. The Company may terminate or suspend the Contest at any time at its absolute discretion in which case, the Company may elect not to award any prize. Such termination or suspension will not give rise to any claim by the Participants. If the Contest is resumed by the Company, the Participant shall abide by the Company's decision regarding resumption of the Contest and disposition of the Prizes.

2. CONTEST ENTRY

3. ELIGIBILITY

4. INELIGIBILITY

4.1. Persons who are ineligible to participate in the Contest are as set out in Schedule A.

5. **DISQUALIFICATION**

- 5.1. The Company reserves the right to disqualify Participants and/or revoke the Prize (at any stage of the Contest) if:-
 - 5.1.1. The Participant is ineligible or does not meet any of the Eligibility Criteria; or
 - 5.1.2. The Participant breaches of the Terms and Conditions or other rules and regulations of the Contest or violated any applicable laws or regulations; or
 - 5.1.3. in the Company's sole determination, it believes that the Participant has attempted to undermine the operation of the Contest by fraud, cheating or deception.



- 5.2. In the event of a disqualification after the Prize has been awarded, the Company reserves the right to demand for the return of the Prize or payment of its value from the ineligible Participant.
- 5.3. Whilst the Company will endeavour to conduct necessary verifications on the eligibility of Participants, failure to disqualify any ineligible Participants shall not be deemed a breach by the Company.

6. WARRANTIES

- 6.1. The Participant represents and warrants with the Company that -

- 6.2. In consideration of the Company offering to the Participant the opportunity to participate in a Contest, the Participant hereby unconditionally and irrevocably;
 - 6.2.1. agrees that if so required by the Company, the winner shall make himself/herself available (without compensation) for the production, recording and publicity of the Contest during the such time and production schedule as may be notified by the Company:-(i) interview (which shall be meaned al) and/on
 - (i) interview (which shall be recorded); and/or

(ii) taking of still photos, audio and/or visual recording for promotions and publicity use. (collectively "Recording").

- 6.2.2. agrees and consents that the Company shall have right and absolute discretion to broadcast the Recording and/or use the slogan, names or nicknames on any of its programmes/channels in whole or in part at the Company's discretion. All copyrights subsisting in the Recording shall belong to the Company absolutely.
- 6.2.3. agrees that where Participants are required to submit any photographs, drawings, pictures, slogans, any materials or other creative works, including voice or video recordings (collectively "Intellectual Property") with the Contest Entry, the Participant warrants that all Intellectual Property Rights in such submission does not infringe any third party intellectual property rights.



- 6.2.4. agrees that the Company reserves the right, at its sole and absolute discretion, to use and exploit the Intellectual Property via any means or media and in any manner and anytime that it deems fit without first obtaining any consent nor making any payment whatsoever to the Participant and/or the Contest winner(s) and/or representatives.
- 6.2.5. confirms that the Participant has read and understood Terms and Conditions of the Contest and the Participant agrees to abide by the said terms and conditions accordingly and agrees to cooperate and to follow all directions given to the Participant.
- 6.2.6. agrees that all Prizes to be awarded in the Contest is contingent upon the accuracy of the information provided and disclosures made by the Participant and the full and complete performance of the Participants warranties, undertakings and obligations hereunder.
- 6.2.7. agrees that the Participant shall not by act or omission, directly or indirectly bring the Company or the Sponsor into disrepute.
- 6.2.8. agrees that the Participant shall not without the prior written consent from the Company publish or disclose any information in connection with the Contest or Prize (including without limitation, to any representatives of media in any form whatsoever).
- 6.2.9. agrees that the Participant shall not give any product endorsement, any interviews or be involved in any articles or reports in respect of the Contest or the Prize with any third party.
- 6.2.10. agrees that the Participant's participation in the Contest and/or Programme does not entitle the Participant to wages, salary or any other compensation.

7. PRIZES

- 7.1. The Prizes for the Contest shall be as set out in Schedule A.
- 7.2. The winners' names will be notified or announced by the Company by such mode and in such manner as set out in Schedule A.
- 7.3. All Prizes must be collected within the Collection Period and at such Collection Venue as set out in Schedule A. Failure to claim Prizes shall



result in the Prizes being forfeited by the Company and the Company, its agents, sponsors and representatives shall have no liability to the Winners in any respect whatsoever.

- 7.4. All prizes are strictly not transferable, assignable exchangeable or redeemable by the Participant in any other form or manner other than that specified by the Company. All specific or special terms and conditions that are attached to the Prize (whether by the Company or its agent or sponsor must be adhered to by the Participant.

- 8.3. The Company's decisions on all matters relating to the Contest (including without limitation, the selection of Participants, play of the contest and/or any resolutions made) shall be final and absolute and binding on the Participants. No discussion, correspondence, enquiry, appeal or



challenge in respect of any decision of the Company will be entertained.

8.4. The Participant shall not dispute nor make any oral or written complaints, public announcements or statements on the same whether during or after the Contest Period.

9. **PROMOTIONAL ACTIVITES**

- 9.1. The Company and/or its affiliates reserve the right to send SMS messages or email notification to the Participants mobile phone numbers or email address containing information and promotional activities regarding any other TVS promotions.
- 9.2. If a Participant does not wish to receive such SMS messages or email the Participant is required to call and inform the Company accordingly.

10. <u>GOVERNING LAW</u>

10.1. The Terms and Conditions of the Contest shall be construed, governed and interpreted in accordance with the laws of Malaysia as applicable in Sarawak.

11. <u>CONFIDENTIALITY</u>

11.1. The Participant shall treat all Terms and Conditions and rules and regulations of the Contest and all information and knowledge obtained by the Participant in relation to and/or in connection with the Contest and/or Programme and/or derived as a result of his/her participation in the same, including without limitation the Company's business and operational details, the contest mechanics, the judging/selection criteria for the Contest (hereafter collectively known as "Confidential Information"), as confidential and the Participant shall, during and after the Contest Period, take all reasonable precautions to prevent disclosures of the Confidential Information to unauthorized persons or entities for any reason whatsoever and undertakes to deliver to the Company all tangible materials embodying the Confidential Information including any documentation, records, listings, notes, sketches, drawings, memoranda, models accounts, reference materials, samples and machines readable media and equipment that is in any way related to the Confidential Information including all duplicates and copies thereof.



12. <u>INDEMNITY</u>

- 12.1. The Participants forever waive, release and discharge the Company, its agencies, sponsors and representatives from and against, any and all liabilities, costs, loss, damages or expenses which the Participant or any party claiming through the Participant hereafter may have arising out of acceptance of any Prize(s) or participation in the Contest including (but not limited to) personal injury and damage to property and whether or not direct, consequential or foreseeable.
- 12.2. The Participant shall indemnify the Company, its affiliates, agent and sponsors from and against all liability, cost, loss or expenses sufferred thereby as a result of the Participant's breach of the Participant's warranties and undertakings and any breach of the Terms and Conditions and/or the rules and regulations of the Contest.

13.1. - 14.3. The Company will not be responsible or liable for

14.3.1. any problem, loss or damage of whatsoever nature suffered by the



Participant or any party due to any delay and/or failure in receiving and sending a Contest Entry as a result of any network, communication, ISP or system error, interruption and/or failure or experienced by the Company the Participant's telecommunication service provider and/or resulting from participation or the downloading of any materials in the Contest. In the event of such error, interruption and/or failure, the Company shall not be responsible or liable for any failure encountered by any Participant to participate in the Contest or any failure encountered by the Company in fulfilling its obligations hereunder.

14.3.2. any error (including error in notification of Contest winners), omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, theft, destruction, alteration of, or unauthorized access to entries, or entries lost or delayed whether or not arising during operation or transmission as a result of server functions, virus, bugs or other causes outside the Company's control.

15. <u>GENERAL</u>

- 15.1. The Company, its agents, sponsors and representatives shall not be liable to perform any of their obligations in respect of the Contest and this Terms and Conditions, rules and regulations in respect of the Contest where they are unable to do so as a result of circumstances beyond its control and shall not be liable to compensate the Participants in any manner whatsoever in such circumstances.
- 15.2. The Participants shall not be entitled to assign any of the rights or subcontract any of the obligations herein. The Company shall be entitled to assign or sub-license the whole or any part of its rights hereunder to any third party as may be determined by the Company.
- 15.3. All rights and privileges herein granted to the Company irrevocable and not subjected to rescission, restraint or injunction under any and all circumstances. Under no circumstances shall the Participants have the right to injunctive relief or to restrain or otherwise interfere with the organization of the Contest, the production, distribution, exhibition and/or exploitation of the Contest and/or Programme and/or any product based on and/or derived from the Contest and/or Programme.
- 15.4. The invalidity, illegality or unenforceability of any terms hereunder shall not affect or impair the continuation in force of the remainder of the Terms and Conditions of the Contest.



- 15.5. The main language of the Terms and Conditions shall be the English language. Any translation to any other language than English shall be for convenience only. In the event of any inconsistency between this English language and any other languages, the English language version shall prevail and govern in all respects.
- 15.6. No refunds or exchange of Prize will be made under any circumstances. Participant / Winner arriving late to the Location will only be permitted entry during times as deemed appropriate based on the discretion of the Company.
- 15.7. Smoking at the Location venue is strictly prohibited except for designated area only.
- 15.8. To be permitted entry to the Contest venue as a Participant, the Participant must not dress in an exceedingly exposed or provocative manner or in any manner deemed unacceptable by the Company. Additionally, the Winner must comply with typical, heterosexual and gender binary norms for dress codes. The Company reserves the absolute right to refuse Winner to venue entry for failing to comply with acceptable dress codes.
- 15.9. The Winner and/or Winner must be able to show, for physical wristband ticket collection purposes, the confirmation email sent to the Winner and the original Identity Card or Passport if required. In the event the confirmation or documents provided are insufficient to verify the identity of the individual and/or Winner, the Company reserves the absolute right to refuse Winner or the Winner to venue entry. No person is allowed to enter the venue without a physical wristband ticket. The Company will not be responsible for any Prize that is lost, stolen or destroyed.
- 15.10. On ground Contest venue access control procedure and method are bound by the Terms & Conditions specified here in and any other provision as may be specified from time to time.
- 15.11. The Company reserves the right to request for further confirmation or documents to verify the identity of the Winner. In the event the confirmation or documents provided are insufficient to verify the identity of the Winner, the Company reserves the absolute right to refuse for venue entry.
- 15.12. Ownership or possession of the Prize does not confer any rights (by implication or otherwise) on the Winner to use, alter, copy and/or



otherwise deal with any of the symbols, trademarks, logos and/or intellectual property appearing on the ticket.

- 15.13. Information is collected from those registering with the Company's representative, agent or any such authorized personnel in order to facilitate ticket or other services available. The information is collected and used in accordance with our Privacy Policy.
- 15.14. The information collected from those registering with the Company in order for marketing promotion will be processed in accordance with the Privacy Policy. By participating, the Participant provides his/her consent to the Company in processing their information and permits sponsors, partners and/or authorised parties to contact Participant to receive marketing materials and communications for future events, promotions and any other marketing and promotional activities.
- 15.15. The Company reserves the right, without refund of any amount paid, to refuse the admission to, and/or eject any person whose behavior does not comply with the rules and regulations set forth by the Company's representative, agent or any such authorized personnel and/or the venue.
- 15.16. Prize is non-transferable and cannot be resold. All Prizes will be rendered as invalid if transferred or resold.
- 15.17. Delay and Postponement
 - i. The Company does not allow any exchange or cancellation of Prize under any circumstances and neither transferrable nor refundable unless otherwise permitted under paragraph below.
 - ii. In the event of postponement, the Prize registered for the original event date may be applicable and valid for the new event date unless otherwise notified.
 - iii. The Company reserves the right to postpone, cancel, interrupt or stop the event due to adverse weather, dangerous situations, or any other causes beyond its reasonable control.

15.18. Cancellation

- ii. In the event any of the performing group is unable to attend or participate, and beyond the Company's reasonable control, no refund can be claimed under any circumstances.
- iii. The Company reserves the rights to change or amend any terms and conditions at any time at its sole and absolute discretion without prior notice.

15.19. Consent

During the Contest (including entry into the Location), the Winner agrees to submit to any search for any prohibited items including but not limited to weapons, controlled, dangerous and illegal substances and recording devices.

15.20. Assumption of Risk
